

**Oakview Primary School  
Parental Involvement Policy  
2018-2019**

Oakview Primary School is committed to the success of students and will make every effort to include parents in the development, evaluation, and revision of the Title I program and Parental Involvement Policy to provide excellence in education.

**PART I. GENERAL EXPECTATIONS**

The Oakview Primary School agrees to implement the following statutory requirements:

- The school campus will put into operation programs, activities and procedures for the involvement of parents consistent with section 1118 of the Elementary and Secondary Education Act (ESSA) for Title I, Part A. Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
- Consistent with section 1118, the school campus will work to ensure that the required school-level parental involvement policies meet the requirements of section 1118(b) of the ESSA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESSA.
- The school campus will incorporate this campus-wide parental involvement policy into its CAMPUS plan developed under section 1112 of the ESSA.

- (C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;*

*(D) the carrying out of other activities, such as those described in section 1118 of the ESSA.*

1. The Oakview Primary School will take the following actions to involve parents in the joint development of its campus wide parental involvement plan under section 1112 of the ESSA:

Oakview Primary School will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school campus will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.

The evaluation will be conducted at the end of the school year during a campus site-based meeting.

6. Oakview Primary School will build the schools and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership

Oakview will encourage and support communication between principals and teachers with parents using phone calls, email and Skyward software; newsletters; and state assessment information.

B. Oakview will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

- Provide Skyward Family Access to online grade books
- Provide teacher e-mail for parent communication purposes
- Provide newsletters
- Provide online resources via the school website
- Provide assistance on how to help with reading homework

C. Oakview will educate its teachers, pupil services personnel, and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- Encourage and support parental involvement in Parent/Teacher conferences
- Encourage staff participation in Region 8 workshops/conferences specific to parental involvement
- Support campus-based staff development parent involvement training

D. The school campus will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- TEA-provided parent documents for understanding test results will be provided in Spanish, as provided by TEA.
- Where appropriate, acquire services of translator to assist with parent meetings
